Registration and Fees:

- Registration contracts are due no later than November 10, 2024. You will receive a
 confirmation email or call when your contract is finalized after 11/13/24. Late contracts
 are accepted only as space permits, on an individual basis. We will contact you.
- All table fees are non-refundable.
- Tables are provided and rental is as follows:

Option 1: 8 ft. table One day rental... \$40

Option 2: 8 ft. table Two day rental....\$60

- All crafters/vendors may stay for Sunday hours, with no additional fee for table rental
- Table skirts will be provided upon request. Table covers are vendors' responsibility
- All vendor's merchandise and staff must fit comfortably on or BEHIND the 8 ft. table. 1-2 chairs will be provided per table. Space for storage under the table available.
- Electricity is available on a first come, first-served basis per application form, and number available depends on how they fit into floor plan. Extension cords are NOT provided. Vendor is responsible for properly and safely setting up any extension cords.
- All vendors are required to man their booths and not tear down till end of day, 4 pm
- Coffee shop with drinks, sweets and daily homemade soups will be available on the premises for purchase
- No commissions will be collected by the GOCHS.
- GOCHS will not collect money on behalf of any exhibitor.
- GOCHS has the final decision on acceptance of crafters/vendors. Handmade products are allowed and preferred. Only one direct sales/marketing representative from different companies will be accepted.

<u>Set up:</u> These times below are available for set –up. <u>ALL BOOTHS MUST BE SET UP BY 10 AM</u> <u>AND REMAIN SET UP TILL 4 PM. If coming for only Saturday, check with organizer for more time.</u>

- Thursday, December 5th, 2024 from 4:00-5:30 pm
- Friday, December 6th, 2024 from 8:00 9:45 am
- Saturday, December 3rd, 2024 from 9:00 9:45 am

Tear down: All vendors are required to remove their table/booth area by 4:00 pm Sunday, if opting to remain for Sunday. If 1 or 2 day rental, then must tear down and remove their items by 5 pm on Friday or Saturday. Teardown may only begin at 4 pm, when daily event ends. GOCHS are not liable for lost, stolen, or damaged merchandise or equipment. Setting up and leaving your merchandise and/or equipment on the premises is at your own risk.

FOOD: Homemade daily soups, some limited snacks and/or baked items and beverages will be available at the café area for purchase, with limited seating. NO outside food sales allowed for this GOCHS Christmas Bazaar event. You may bring your own personal snacks to keep at your booth.
